2020 Census Preparation

As we gear up for the 2020 US Census, Division of Planning staff are reviewing and updating the Census Bureau's residential address list with the most recent RIGIS E911 residential addresses: this is known as "LUCA" (Local Update of Census Addresses). We have focused on the twenty municipalities that did not participate in the program and, more specifically, group quarters such as dormitories, nursing homes and group housing, which are the types of homes that are most likely to be overlooked.



This process is important for making the 2020 Census as accurate as possible. It is the only opportunity to review and comment on the Census Master Address File prior to the 2020 Census and is relied upon to distribute the Census forms and for non-response follow-up. Under counting the population will have impacts on how the more than \$200 billion in Federal grant funding gets distributed to states and local governments, as well as the number of Congressional seats that Rhode Island will have. TIP News



In September, the Division of Statewide Planning hosted a two-day peer exchange in Providence, with the theme of "Exploring a Transition to an Electronic Statewide Transportation Improvement Program ("e-STIP") and Improving the Transportation Alternatives Set-Aside Program." The Rhode Island participants learned a great deal from peer agencies during the exchange, especially about the ways in which an e-STIP is implemented and managed, how an online STIP project application intake tool may be utilized, and how they select, manage, and fund projects in the Transportation Alternatives Program (TAP). In the coming months, the Division of Statewide Planning (along with RIPTA and RIDOT) will be working to

restructure the STIP, including many of its processes and software applications, allowing Rhode Island to use best practices, particularly with regard to the application and solicitation process, project prioritization and selection, and project funding. The Division will also be working with the GIS software company ESRI, and hopes to adopt a series of STIP software applications and solutions.

Because of these upcoming changes, there will be no STIP project solicitation this year. We will instead focus our efforts on modifying and improving the way the STIP works to ensure that future solicitations will be more inclusive and effective.
