The Rhode Island Department of Administration, Division of Statewide Planning has received the Rhode Island Department of Transportation's (RIDOT) October 1, 2020 – Request for Administrative Adjustment to the FFY2018-2027 State Transportation Improvement Program (STIP).

The proposed changes to the STIP in this request include 22 unique actions: nine (9) in the Bridge Capital Program, one (1) in the Maintenance Operations Program, four (4) in the Pavement Capital Program, seven (7) in the Traffic Safety Capital Program, and one (1) in the Transportation Alternatives Program. The net result of the changes is an addition of \$29.7885 million over the constrained period (FFY 2018-2021) and a total addition of \$\$161.6085 million over 10 years (FFY 2018-2027). The funding additions are in response to two positive developments in federal funding: [1] recently awarded USDOT discretionary grants, and [2] additional obligation limitation made available through FHWA's August Redistribution Process.

I have reviewed RIDOT's request according to the Memorandum of Agreement governing Procedures to Amend and Modify the State Transportation Improvement Program executed June 4, 2020. I find that this request constitutes an Administrative Adjustment under the Memorandum of Agreement and is hereby approved.

The documentation submitted indicates that fiscal constraint of the STIP will be maintained. For record keeping purposes, please note that this Administrative Adjustment shall be referred to as approved Revision #28 to the FFY2018-2027 STIP. Revised STIP tables incorporating the modifications are enclosed.

SUBJECT:	Request for Administrative Adjustment to the FFY2018-2027 STIP

The purpose of this memorandum is to summarize the proposed Administrative Adjustment to the FFY2018 – FFY2027 TIP. The net result of the actions described herein is an addition of **\$29.7885M** over the constrained period (FFY2018 – FFY2021) and a total addition of **\$161.6085M** over 10 years.

The funding changes proposed in this adjustment do not represent an increased capacity to complete additional projects. Rather, the funding additions are in response to two positive developments in federal funding: [1] recently awarded USDOT discretionary grants, and [2] additional obligation limitation made available through FHWA's August Redistribution Process.

Just this morning, Congress passed a continuing resolution to allow the distribution of federal funding through September 30 of next year, but it is not clear what federal formula funding will be available thereafter. In addition, as you know, the impacts of the COVID-19 pandemic on the state budget for the 2021 fiscal year and beyond are still being determined. The outcomes of both state and federal budgeting processes may have a considerable impact on the funding sources available to support the STIP. RIDOT anticipates a future amendment may be needed once the budgetary picture becomes clearer, to continue to maintain fiscal constraint.

The proposed changes to the STIP in this request include 22 unique actions: 9 in the Bridge Capital Program, 1 in the Maintenance Operations Program, 4 in the Pavement Capital Program, 7 in the Traffic Safety Capital Program, and 1 in the Transportation Alternatives Program.

A summary of the funding use changes by program during the constrained period (FFY18-21) can be found below.

Pursuant to the Memorandum of Agreement governing Procedures to Amend and Modify the State Transportation Improvement Program executed June 4, 2020, the proposed revisions summarized herein constitute an Administrative Adjustment for the following reasons:

- 1. The addition of funding to Bridge Groups 62T (K), 32, 96, 95, and 51B are all justified by the provisions in **Section IV § B.1.c.ii** which allows the addition of federal discretionary and annual August Redistribution funds to projects already listed in the fiscally constrained years of the current STIP to be processed as an Administrative Adjustment;
- 2. The division of Bridge Group 17A into two groups (the other being Bridge Group 37) is justified by **Section IV § B.1.b.iii**, which allows for splitting up a bridge group to be processed as an Administrative Adjustment;
- 3. The funding adjustments to Bridge Group 57E and TIP IDs 7503, 9201, and 7302 all fall within the standard Administrative Adjustment funding revision threshold of 35% for projects under \$10 million as established in **Section XIV Exhibit A1**;
- 4. The removal of TIP ID 1292, which is being consolidated into Bridge Group 96, is justified under Section IV § B.1.b.iii, which allows Administrative Adjustments to include "combining multiple projects in the STIP, if scope and limits remain the same overall," which they do in this case. The funding reduction to TIP ID 1512 also falls within the parameters of this provision because the remaining scope of work in TIP ID 1512 will be completed as part of Bridge Group 96; and
- 5. The cash flow adjustments to TIP IDs 1392, 1509, 9605, 9609, 1443, 9601, 5219, and 5309 all fall within the standard funding thresholds mentioned in Item 3 above, or, where applicable, the 30% funding revision threshold for projects with budgets greater than \$10 million as established in **Section XIV Exhibit A1**.
